- Proof of guardianship is required is required for registration, if the enrolling adult is not the birth parent;
- Agreement of Release of School Records Form
- Student's birth certificate or passport or Parent or legal guardian's identification (government issued ID)
- Non-refundable registration fee
- Current immunization records (form 3231) OR a notarized exemption letter from the legal guardian
- Eye, Ear and Dental Screening (Form 3300) for 5 year old or students entering kindergarten
- Copies of any previous school records
- Emergency form
- Financial agreement contract
- Satisfactory scores on placement tests
- Parents must read and sign form in Student/Parent Handbook

APPLYING TO IQRA ACADEMY

An Application for Admission must be submitted and testing fees paid prior to applicant's screening. Since the number of openings at each grade level is limited, parents are encouraged to complete and submit the application materials as soon as possible.

NEW APPLICANTS

A school visit and interview are required of all applicants and their parents. Visiting parents and students meet with the school staff. These visits provide an opportunity for prospective students to experience Iqra Academy firsthand.

APPLICANT SCREENING

New applicants will be tested individually at the time of their classroom visit or at another mutually convenient time.

ADMISSIONS CRITERIA

Iqra Academy thoroughly reviews each completed application, including the applicant's past school experience and academic performance, interests, test results, teacher recommendations, and school visits. In some cases, an applicant may be asked to complete additional testing. Iqra Academy's goal is to ensure that a good match is made between the applicant and the school.

The following contract is being established between the Parent/ Guardian _____ and Iqra Academy. The parent/guardian agrees to enroll _____, _____, and _____, at Iqra Academy beginning _____.

The parent/guardian further agrees to the following terms and conditions:

1. Submitting a non-refundable application fee along with the completed Application for Admission before the first day of classes.

2. Tuition and Fees:

- PreK3 & PreK4: \$2,500; Registration Fees: \$150; Activity fees: \$100
- Kindergarten: \$3,000; Registration Fees: \$150; Book Usage fees: \$300
- Grades 1-2: \$3,000; Registration Fees: \$150; Book Usage fees: \$400
- Grades 3-6: \$3,000; Registration Fees: \$150; Book and Technology fees: \$150

3. If a child remains absent from Iqra Academy for a day, several days, or week(s), etc, the weekly tuition fee is not waived.

Preschool hours: Mon.-Thu. 9 am – 1 pm; Fri. – No Preschool

Gr. K - Gr. 6 School hours: Mon.-Thurs. 9 am – 2:30 pm. Friday 9 am – 1:30 pm

Students should be picked up by dismissal time, and will incur the late pickup fee of \$2.00 / min after dismissal time. This fee is due in cash at the time of the late pick-up. The student will not be allowed to attend class unless all fees are paid.

4. If the child is to be permanently withdrawn from the school, the tuition refund policy will be as follows:

20% refundable if the child withdraws before the first day of school

15% refundable if child withdraws by 1:30 pm on Friday in the first week of school

10% refundable if child withdraws by 1:30 pm on Friday in the second week of school

5% refundable if child withdraws by 1:30 pm on Friday in the third week of school

0% refundable if child withdraws any time after Friday 1:30 pm in the third week of school

5. I understand that the child(ren) for whom tuition or other fees are not paid in a timely manner, would not be allowed to attend.

6. If it is necessary to employ a professional collection agency and/or attorney to enforce or to collect a judgment based upon this agreement, the undersigned parent/guardian will be responsible for paying all expenses accrued including, but not limited to, collection agency fees, court fees, and attorney fees. I have received and read the Iqra Academy Parent Handbook. I fully understand its contents and will abide by all the rules and regulations. ALL PAYMENTS MUST BE PAID BY CHECK; ALL CHECKS MUST BE MADE PAYABLE TO: IQRA ACADEMY. I AGREE TO THE ABOVE TERMS AND CONDITIONS. ANY CHANGES TO THIS AGREEMENT WILL BE DISCUSSED IN ADVANCE AND A NEW AGREEMENT WILL BE SIGNED.
